Alto Clutch Plates SDS

When used as intended, Alto Clutch Plates meet OSHA's definition of an article and are exempt from the Hazard Communication Standard. Do not drill, saw or grind bonded friction material to avoid the release of nuisance dust. Being exempt Alto Clutch Plates do not require a Safety Data Sheet (SDS).
